Dear Valued Customer,

The products that Pelham Plastics Inc manufactures are done so in our facility in Pelham, New Hampshire. Please note that Pelham Plastics does not test products for compliance analysis. The information provided is based upon information from raw material and component suppliers, product composition, and Pelham Plastics Inc. manufacturing process knowledge.

REACH Declaration

In accordance with Article 59 of the European Union Regulation 1907/2006 on Registration, Evaluation, Authorization, and Restriction of Chemicals (REACH), the European Chemicals Agency periodically publishes lists identifying Substances of Very High Concern, or SVHCs. The SVHC list was updated on *January 23, 2024*, increasing the number of substances from 235 to 240. The products manufactured by Pelham Plastics do not have any of these SVHCs intentionally added, and therefore we believe are not contained above 0.1% by weight.

RoHS 2 Declaration

RoHS is defined in Directive 2011/65/EU and sets restrictions on using certain hazardous substances in electric and electronic equipment. RoHS specifically restricts the concentration of the following materials: lead, mercury, hexavalent chromium, polybrominated biphenyls (PBB), polybrominated diphenyl ethers (PBDE), and other polybrominated compounds to a level equal to or less than 0.1% by weight. It further restricts the use of cadmium to equal to or less than 0.01% by weight. On June 14, 2022, the European Delegated Directive (EU) 2015/863 added *two new substances* to the EU RoHS Directive. The restrictions for these additional substances enter into force on *June 14, 2023,* for all electrical and electronic equipment (EEE) excepting Category 8 and Category 9 products. The products manufactured by Pelham Plastics do not contain any of the RoHS listed chemicals and is compliant with both of the RoHS Directives.

Medical Devices Regulation

The EU Medical Devices Regulation, MDR 2017/745, sets high standards of quality and safety for medical devices in order to meet common safety concerns regarding such products. The regulation specifically restricts certain carcinogenic, mutagenic, and reproductive toxins (CMR) and endocrine disrupting chemicals (EDC). CMR's and EDC's must be limited to a concentration below 0.1% by weight unless justification for their use can be provided. The products manufactured by Pelham Plastics do not contain any of the restricted substances listed in the MDR regulation.

The above statements are based on information available at this point in time and are believed to be accurate. Please consider this information confidential and privileged. Pelham Plastics Inc. will keep track of any relevant changes regarding this compliance certificate and keep customers informed of any updated information.
